Enclosed please find a copy of Section 1040 of the Zoning Regulations as a reminder of your responsibility to notify property owners within 100 feet of the 10 Nearwater Lane, 18 Hoyt Street, 395 Mansfield Avenue, 133 Mansfield Avenue, and 7 Old Farm Road properties of this pending application. A copy of the Legal Notice is enclosed for your use in this process. You must send the mailings between September 30, 2020 and Saturday, October 10, 2020. **Our office is providing you with the attached mailing list that you should use for the required mailings.** NOTE: A recent order from the Governor allows the mailings to be completed by regular mail, rather than certified/return receipt requested.

Once you have sent the mailings, you are required to submit the following to the Planning and Zoning Office *by the Wednesday prior to the public hearing*: a copy of one (1) of the letters sent to the property owners within 100 feet, with the enclosure which was sent to them; and a list of those property owners within 100 feet.

The public hearing on this application has been scheduled for **Tuesday, October 20, 2020 at 8:00 P.M. in Darien Town Hall and via GoToMeeting.** A login number for GoToMeeting will be provided to both you and the general public a few days prior to the meeting via the Town of Darien web site.
