The Regulations Were Comprehensively Revised, Effective June 6, 1958. The Second Comprehensive Revision of The Regulations Became Effective July 1, 1979. This Current Comprehensive Revision Became Effective April 5, 1992. Any Amendments Since That Time Are Included, within Appendix B, Schedule of Amendments.

The latest amendment became effective on June 7, 2009.
