**APPOINTMENT OF KEVIN TREESH TO THE WESTERN CONNECTICUT
TOURISM DISTRICT FOR A TERM ENDING 6/30/22**

**** MONICA MCNALLY, DISTRICT II, MOVED:**

WHEREAS, the Connecticut General Statutes Section 10-397 provides for the establishment for the Regional Tourism Districts; and

WHEREAS, the Town of Darien is a member of the Western Regional District; and

WHEREAS, the statute provides that each Tourism District shall be overseen by a Board of Directors consisting of one (1) representative from each municipality within the district; and

WHEREAS, the statute provides that said member of the Board of Directors shall be approved by the legislative body of the municipality.

NOW THEREFORE, BE IT RESOLVED, that the Representative Town Meeting of the Town of Darien hereby appoints Kevin Treesh to the Western Regional Tourism District as the representative of the Town of Darien.

BE IT FURTHER RESOLVED that the appointment shall commence upon the adoption of the resolution for a term ending June 30, 2022.

**CONSIDERATION AND ACTION ON THE ISSUING OF A DRAINAGE EASEMENT
BEING ISSUED TO THE STATE OF CONNECTICUT ON THE OX RIDGE SCHOOL
PROPERTY**

The Moderator said they had received a few changes in the wording of the easement this afternoon, but these were not material changes.

Town Attorney Wayne Fox said this easement is needed in order to go out to bid. The change is of no significant modification to what has been voted on. The Town is not giving up land per se.

Amy Barsanti, District I, PZ&H, asked, re the language, if there were any material changes on the map. Jeremy Ginsberg, P&Z Director, said what had changed on the map was the name of the Chief Engineer and "right to drain" had changed to "easement to drain".

**** AMY BARSANTI, DISTRICT I, CHAIRMAN OF PZ&H, MOVED:**

WHEREAS, the Town is about to undertake a major renovation project with respect to the Ox Ridge Elementary School; and

WHEREAS, the Ox Ridge Elementary School abuts a state highway commonly referred to as Connecticut Route 124; and

WHEREAS, the State of Connecticut considers the school to be a major traffic generator and therefore, requires a permit from the Office of State Traffic Administration (OSTA); and

WHEREAS, as a condition for application of the permit, the state requires an Easement to Drain over the Town property; and

WHEREAS, the Easement to Drain would formalize conditions that currently exist on said property.

NOW THEREFORE, BE IT RESOLVED, that the Representative Town Meeting of the Town of Darien hereby authorizes said Easement to Drain and authorizes the First Selectman to execute documents to establish said Easement to Drain, all of this as more particularly set forth in the documents and map attached hereto and made a part hereof.

Resolution 20 – 22 authorizing an Easement to Drain to the Department of Transportation of the State of Connecticut

Report of RTM Education Committee

The Education Committee met on Thursday, September 17 with nine of 13 members present to discuss this resolution. David Dineen, Vice Chair of the Board of Education and Co Chair of the Ox Ridge Building Committee and Alan Addley, Superintendent of Schools joined the meeting along with Will Walter of Tighe and Bond.

The Education Committee was asked to report on this item because as a condition of approval of the OSTA permit, the State is requesting a drainage easement on the Ox Ridge property. It is noted that the easement formalizes an existing condition.

Concern was expressed by the Committee that use of the word easement was too broad in scope, allowing DOT CT access to the Ox Ridge property forever as described in the language of the supporting documents. It was suggested that we see if language could be used to limit the scope of the easement. Will Walter of Tighe and Bond explained that the intent was to have water go over the site, that the easement was for a right to drain and that from an owner point of view, the language used was preferable.

Committee members suggested that we contact Jeremy Ginsberg of Planning and Zoning to see if he could provide clarification and he did so noting that the Town Council had reviewed and written much of the Easement to Drain Documents based on guidance from the OSTA/DOT.

The committee voted unanimously to approve this resolution and recommends that the RTM do the same.

Report of the Education Committee

The Education Committee met on Thursday, September 17 with nine of 13 members present to discuss this resolution. David Dineen, Vice Chair of the Board of Education and Co Chair of the Ox Ridge Building Committee and Alan Addley, Superintendent of Schools joined the meeting.

The Education Committee was asked to report on this item because it includes funds intended for reimbursement for the Darien Public Schools based on expenses through June 30, 2020.

David Dineen explained the process that the Board of Education will use to request reimbursement for expenses related to Covid 19. He referenced a memo prepared by the District on Guidance on Allowable Expenses. The District has incurred expenses of more than \$2 million for personnel, cleaning, PPE, health and transportation relating to Covid -19 to date.

The Education Committee voted unanimously to authorize submission of this request to the State of Connecticut under the Municipal Corona Virus Relief Fund in the amount of \$ 40,282 and asks that the RTM do the same.

The State of Connecticut received federal CARES Act funds. The State established the Municipal Coronavirus Relief Fund (CRF) program to provide municipalities with reimbursement for Covid-19 related expenses. Darien's allocation is \$40,282 for reimbursement of expenditures through June 30, 2020. It is expected that the State will allocate additional funds for expenditures incurred after July 1, 2020.

The submission for CRF funds must be authorized by the RTM. A final report of the invoices and amounts to be submitted will be provided prior to the RTM meeting.

Municipalities must maximize other available federal funding sources before seeking reimbursement through the CRF program. Town and BOE expenditures and funding sources are as follows:
